To avoid confusion, it is best to avoid using the term “margin of error” or “margin of sampling error” in conjunction with non-probability samples.</p>	<p>The general election sample consisted of early voters and very likely voters in Alabama, n=1,000 with a Credibility Interval (CI) similar to a poll’s margin of error (MOE) of +/- 3 percentage points.</p> <p>The Democratic primary sample consisted of likely voters, n=294, with a Credibility Interval (CI) similar to a poll’s margin of error (MOE) of +/- 5.7 percentage points.</p> <p>The Republican primary sample consisted of likely voters, n=706, with a Credibility Interval (CI) similar to a poll’s margin of error (MOE) of +/- 3.6 percentage points.</p> <p>A screening question was asked if the voter was a very likely voter. If the respondent said they were not very likely to vote, they were eliminated from the sample.</p>
